- **How to apply :**


Interested candidates may appear for the interview with two sets of self attested copies of SSC/10th Standard Certificate or equivalent proof of date of birth, MBBS, PG Degree Certificate, Attempt Certificate of MBBS valid MCI/Registration Certificate, SC/ST/OBC certificate and experience certificate, etc. along with originals. The candidates should also bring two recent passport size photographs along with proof of residence. The candidate who is currently in the employment must bring experience certificate (working certificate) and No Objection Certificate, failing which his/her candidature will be liable to rejection.

- **Note :** Candidates claiming reservation/age relaxation on grounds of belonging to OBC should submit the community certificate in prescribed proforma vide Govt. of India, Department of Personnel and Training O.M. No. 3601/22/93-EST (SCT) dated 08/09/1993 which is modified vide OM No. 36033-3-2004 Estt.
